| Dismissal | Students may be dismissed from the program if they are still participating at an "Inadequate" level after a 90 day action plan and contract. If a student is dismissed, parents may apply for readmission to the program after one year. <i>Students will not be dismissed for a lack of mentor or parental support as long as that student is still trying to meet the BRMA participation requirements.</i> | | | |
